



General Terms and Conditions


1. Blue Classroom ensures that the course, training or event is provided by a qualified instructor, in active status. As a recognized Freedive Center for PADI, AIDA and Molchanovs, Blue Classroom ensures to adhere to the standards and procedures prescribed by the respective organizations.
2. Registration for a course is only possible by means of a fully completed and signed registration form, as well as a deposit. As soon as the form and the deposit have been received by us, a place on the course is definitively booked for the student.
3. A "Medical statement" is required prior to a course, training or event, if necessary, also signed by a physician. All forms about the understanding and risks of freediving should be signed. You will receive these forms together with the registration form. For PADI courses you fill in the forms online when you start the e-learning.
4. Registration takes place in order of receipt after receiving a signed registration form and a deposit.
5. Cancellation of a booked course is possible up to 4 weeks before the start date. In case of cancellation between 4 and 2 weeks beforehand, 50% of the total course fee is due. In case of cancellation in the last 2 weeks, the student/participant is due 100% of the total course fee. In case of cancellation, we always charge the costs for teaching materials.
6. In case of non-appearance of the student/participant, the full course fee is due.
7. Students/participants register for the entire duration of the chosen course or event. Interim cancellation or termination, for whatever reason, does not entitle you to a refund.
8. If a student cannot follow the pace of the course due to personal circumstances or cannot master the skills and/or all theoretical requirements within the normal lessons, the course must be terminated or private lessons can be decided upon in consultation. Additional costs can be charged to the student.
9. Cancellation of a lesson is only possible in case of illness or serious circumstances. In case of cancellation of a lesson, you are requested to notify us 24 hours in advance. Costs to make up for the missed lesson – if possible – can be charged to the student.
10. Blue Classroom enables the student to participate in all parts of the course if he or she cannot attend one or more parts due to illness. A new date will be determined in consultation. Blue Classroom reserves the right to charge extra costs in this case if the student (due to illness) is unable to meet the course requirements within the normal program as booked. In case of illness during the course, a new medical certificate may be required, which may have to be signed by a physician.
11. A deposit of 30% of the course/event fee must be paid upon registration. The remainder must be paid no later than 3 weeks before the start of the first lesson. If the start of the course is less than 3 weeks away at the time of registration, the entire amount must be paid upon registration.
12. The student/participant is obliged to take good care of the equipment of Blue Classroom.
13. Blue Classroom and/or the instructor(s) reserve the right at all times to refuse a student without further explanation. If this happens during a course that has already started, the student is liable for the full course fee.
14. The undersigned of the registration form also declares that he/she indemnifies Blue Classroom and the instructors/guides acting on behalf of this diving center from all liability that directly or indirectly arises from or is the result of the diving training courses or events provided by him/her.
15. By registering, the student/participant indicates that he/she accepts these conditions. These conditions govern the legal relationship between Blue Classroom and the student/participant, unless expressly agreed otherwise in writing.
16. BES law applies to all agreements with Blue Classroom to which these general conditions apply. In case of disputes, one can report to the Court of First Instance of Bonaire, Sint Eustatius and Saba, sitting in Bonaire.
